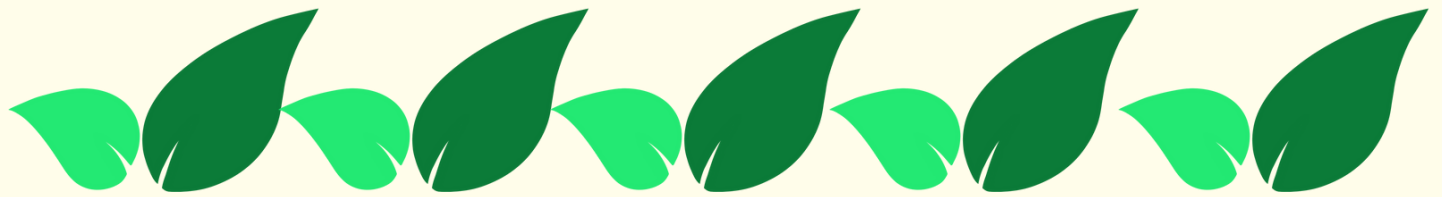

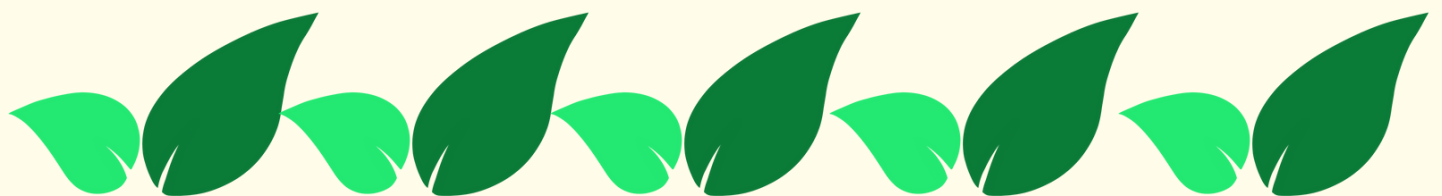

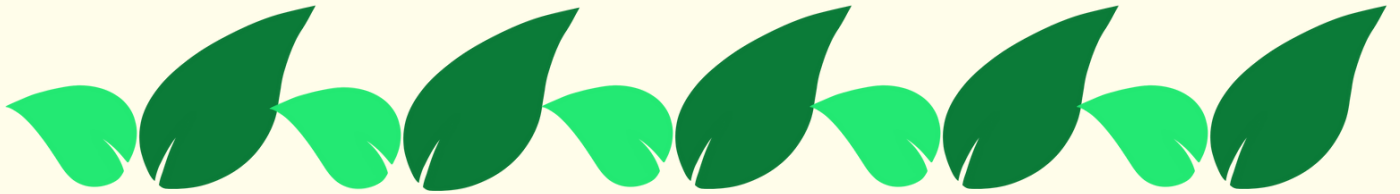




OBJECTIVES



In alignment with the goals of the UN 2030 Agenda and the priorities of the European Green Deal, through the **SOStenibile 2023** project, the Consortium, led by the **Istituto Omnicomprensivo Fratelli Agosti of Bagnoregio (VT)**, intends to improve the quality of vocational education and training, providing a European dimension to educational pathways and thus offering young participants the opportunity to verify and deepen their curricular skills or rather their professionalism in the specific field of belonging to **Environmental and Land Management of Environmental Biotechnology, Agricultural and Wine sectors and related and/or complementary courses**, in addition to cultural knowledge and language preparation. This overall objective is pursued through an international mobility experience consisting of an **ERASMUS internship intended lasting an average of one month for students in initial vocational training and three-month mobility to recent graduates at Consortium schools**. The work program includes an internship experience in selected companies in the environmental and agricultural sector that have invested in R&D and adopted innovative eco-friendly practices for the preservation of the environment and land, to gain knowledge and skills of that professional area and compare different professional techniques.



It also provides for activities to support integration into the host context through learning and understanding the foreign language, the sector and the **cultural heritage** of the area.

The Consortium, with VET accreditation, thus renews its EUROPEAN DEVELOPMENT PLAN and its drive toward internationalization of institutional relations and cooperation at the international level.

Opportunities for economic and social growth cannot be separated from the desire to create a strong interdependence and synergy between the world of education and vocational training and local institutions as well as solid partnerships with foreign companies.

EXPECTED IMPACT AND LONG TERM BENEFITS



- enhance the personal and professional skills of participants, as well as those of staff involved in project management;
- increase the employment potential of participants;
- promote active citizenship;
- the introduction of innovative and complementary training methods to enhance the educational offerings of the technical and professional institutions involved;
- the construction of a permanent transnational network through the development of the relationship, cooperation and exchange of good practices between the parties involved, with a significant impact on the improvement of training and vocational guidance (technical excellence, good practices in training policies and governance system);
- the recognition of skills in a framework compatible with ECVET.
